BECOME A CHMM

The Certified Hazardous Materials Management (CHMM) credential recognizes your expertise and opens new possibilities for you to make a significant impact on your community and your country. Corporations, universities and government agencies depend on the CHMM credential to identify hazardous materials professionals just like you. All candidates for CHMM certification must have a baccalaureate degree (or higher) from an accredited college or university, plus at least 4 years of appropriate experience in the field of hazardous materials management. In addition, they must pass a rigorous multiple-choice examination developed by the Institute of Hazardous Materials Management, which tests a candidate's ability to:

- I. Recognize, Identify and Characterize Hazards of Materials
- II. Assess Risks Related to Hazardous Material
- III. Mitigate and/or Eliminate Hazards of Materials
- IV. Manage Impacts of Hazardous Materials on the Environment
- V. Manage Impacts of Hazardous Materials on Human Health
- VI. Ensure Regulatory Compliance
- VII. General Management of Hazardous Materials, and Business Skills

Once the candidate has successfully completed these requirements, he/she must pledge to maintain the highest standards of integrity through the CHMM Code of Ethics and must demonstrate continued competence by undergoing recertification every five years.

Additional certifications are available for Certified Hazardous Materials Practitioners (CHMPs), Hazardous Materials Manager-in-Training (HMMT) and Certified Dangerous Goods Professional (CDGP). Please see the Institute's web site for more information: <http://www.ihmm.org>
